Fees and other charges levied by the Commission for various services

Section 5(1)(g) of the University Act, Cap. 346 R.E 2023, gives the Commission the mandate to levy fees or any other forms of charges for specific services, facilities, and documents rendered or supplied to institutions. Since July 2014, the Commission has approved various fees and charges as follows:

1.	Application for establishment of university institution	TZS. 5,000,000 for local investor and USD 5,000 for foreign investor
2.	Annual fees for university institutions	TZS. 5,000,000 per annum
3	Lodging of charter and review of approved charter	TZS. 2,500,000
4.	Technical evaluation of university institution	Actual costs plus 30% administrative costs paid upfront before evaluation is done
5.	Validation and accreditation of new programme	Actual costs plus 30% administrative costs paid upfront before evaluation is done
6.	Quality assurance for students enrolled in university institutions	TZS. 20,000 per annum
7.	Application for establishment of Overseas Student Recruitment Agency	TZS. 3,000,000
8.	Annual subscription fees for Overseas Student Recruitment Agency	TZS. 2,500,000 per annum
9.	Processing applications and issuing certificates of no objection to individuals who have secured admission to pursue studies at overseas universities	TZS. 50,000
10.	Evaluation and recognition of foreign award	<ul style="list-style-type: none"> • TZS. 100,000 for Certificate, Diploma and Bachelor's Degree • TZS. 150,000 for Postgraduate Certificate, Postgraduate Diploma, Master's and PhD awards
11.	Appeal for evaluation of foreign award and recognition of qualification	<ul style="list-style-type: none"> • TZS. 100,000 for Certificate, Diploma and Bachelor's Degree • TZS. 150,000 for Postgraduate Certificate, Postgraduate Diploma, Master's and PhD awards
